Rules & Guidelines

RULES:

1. ONLY youth-based (18 and under) nonprofit organizations and clubs from Temescal Valley or El Cerrito can participate (includes schools that serve the communities of Temescal Valley and El Cerrito). Applications from organizations that are not locally focused will not be considered.
2. Children between the ages of 11 and 17 are allowed to participate with parent/guardian permission. Children under the age of 14 must be accompanied by an adult at all times.
3. Organizations must have 501(c)(3) status with the IRS and provide proof of status. This must be submitted with the application.
4. Organizations must provide proof of liability insurance certificate.
5. Volunteer waivers must be completed **by all participants or their guardians** and submitted prior to each cleanup to the event coordinator.
6. A maximum of three cleanups per year, per group.
7. Up to \$500** will be awarded per group, per cleanup, with a minimum of 10 participants. Groups more than 10 participants will not receive additional funding.

GUIDELINES:

1. Cleanups will take place between the hours of 9 a.m. and 12 p.m. on Saturdays (3 hours).
2. Minimum of 10 participants per group, including the team leader, must attend the day of the cleanup. NO EXCEPTIONS.
3. Team leader must be 18 years of age or older and are responsible to conduct training and oversee all participants.
4. Safety training is mandatory for all team leaders, who must then train all group members prior to the cleanup day.
5. Team leaders will receive cleanup location and directions prior to cleanup day. Illegal dumpsites will be within the communities of Temescal Valley and El Cerrito.
6. Each group must provide their own group leader, transportation, food, and water.
7. Equipment will be provided to all participants and may include: gloves, safety vests, trash pickers (to be returned), and trash bags.
8. Groups will receive their money reward five to six weeks after the cleanup day.

DISCLAIMER:

The County of Riverside is not responsible for any injuries that may occur while at a cleanup site. Safety equipment such as gloves, trash bags, trash pickers, and safety vests will be provided.

Volunteer waivers must be submitted to the event coordinator prior to each cleanup with the exact name of person volunteering. Participants in this Clean Money Fundraising Opportunity waive and release the County of Riverside its agencies, departments, officers, representatives, employees and contractors ("County Representatives") from any and all liability in connection with the cleanup. Applicants shall indemnify, defend and hold harmless the County Representatives from any liability, claim, damage or action whatsoever arising out of or related in any way to the Abatement or this consent.

All funds must be used for products and services of your organization and must be reported to the IRS as specified in your nonprofit 501(c)(3) agreement. Proof of liability insurance MUST be submitted prior to cleanup date.
