Riverside County Code Enforcement is responsible for enforcing Riverside County codes and taking steps to improve your community. We need your help to provide a safer and more attractive community. As a volunteer you would be responsible for duties such as:



#### Community Outreach

Reporting graffiti and illegal dumping

Distributing Educational information to residents and businesses



Volunteers are expected to provide a minimum of 12 hours per month of service. Mandatory meetings will be held. Training sessions may also come up, which volunteers must attend. Training will include a basic introduction to the Code Enforcement Department and explain responsibilities in Riverside County.

#### To Apply:

- ⇒ Complete and turn in a Volunteer Application and waiver of liability form. (Resume optional)
- ⇒ After an initial review, interviews will be scheduled.
- ⇒ If selected after the interview, Fingerprinting is required. Applicants may not have a disqualifying criminal record.
- ⇒ A Department of Motor Vehicles records check will be conducted to verify driving status.
- ⇒ If you are under the age of 18 a parent or guardian must sign the liability form .

### RELEASE OF LIABILITY AND INDEMNIFICATION

In consideration of the permission granted by the **Riverside County Department of Code Enforcement, and the landowner (s)** of the property on which the activity is to take place (collectively the "Participating Entities") to participate as a volunteer in a clean-up (the "activity" of the area located on or near

I, the undersigned participant, (or legal guardian, if minor), agree as follows:

- 1.) I understand the term site includes the above-mentioned areas in and bordering the unincorporated area of Riverside County and that the term activity includes travel to and from site.
- 2.) I fully recognize the dangers of participating in the activity and I voluntarily assume all risks of injury associated with my participation. The dangers that may encounter include, but are not limited to: terrain, vegetation, potential sharp objects, quickly changing weather conditions, and roadside hazards.
- 3.) I have been properly instructed in and understand the use of any equipment that I am to use in the activity. I realize that my participation in the activity may require sustained strenuous physical activity. I am in good health, and am not aware of any physical or medical condition that might endanger myself or other participants in the activity. If I am taking any prescribed medication, I agree to carry such medication with me at all times.

Acting for myself and my heirs, personal representatives, executors, assigns and guardian ad litem, I hereby release the Participating Entities, and each of their agents, representatives, volunteers, employees, contractors, officers, directors, share holders, successors-in-interest and all persons acting by, through, under or in concert with them (collectively referred to as "Agents") from any and all claims and liability for injury to or death of any person, including myself, and for any damage to or loss or destruction of any property, including my own arising from or related to my participation in the activity or during travel to or from the site whether or not arising from the negligence of the Participating Entities and/or their Agents.

I further agree to indemnify and defend and hold harmless the participating Entities and their Agents from any and all claims and property of the undersigned arising from my participation in the activity or during my presence on or travel to or from the site whether or not arising from the negligence or other acts or omissions of the Participating Entities and/or their Agents.

I expressly agree that no warranty or representation of any kind whatsoever has been given to me regarding the conditions of the site or any facilities or equipment thereon or any means of transportation to and from site, and agree furthermore, that the Participating Entities and their Agents shall not be liable for any alleged negligence or other acts or omissions pertaining thereto.

7.) I assume full liability for any injury to or death of any person arising by reason of my participation in the activity, presence on the site, or travel to and from the site or for any damage to or loss or destruction of property on the site caused by me.
